

RESOLUTION 11-14

**A RESOLUTION AMENDING THE MASTER FEE SCHEDULE BY
CHANGING THE PARKS & RECREATION FEES SCHEDULE
FOR NORTH LOGAN CITY**

WHEREAS, North Logan City has established a master fee schedule to list and regulate the charges for various services within the city; and

WHEREAS, the City Council has determined there is a need to modify the Parks & Recreation Fee Schedule.

NOW, THEREFORE, be it resolved by the City Council of North Logan, Utah, that the Parks & Recreation Fee Schedule, as listed in the Master Fee Schedule shall be changed as follows (highlighted portion added, crossed through items deleted):

Reservation Fee for Park Facilities or Library Meeting Room	\$10.00 (Resident) \$20.00 (Non-Resident) (non-refundable)
Reservation and Use Fee for scheduled use of Conference Room in City Office or Training Room in Public Safety Building	\$10.00 (Resident) \$20.00 (Non-Resident) (non-refundable) Any after-hour reservations of these facilities will also require a \$100 Key/Cleaning Deposit. No key/cleaning deposit is needed for use during business hours or when a city official is to be in attendance and responsible for the facility's use.

Key deposit	\$100.00 (if issued for needed access to restrooms)
Field Line Prep Fee (Baseball/Softball only)	\$20.00 (if requested) – (per field prepared/chalked)
Volleyball Pit	(no difference between resident or non-resident)
Reservation Fee	\$10.00 (non-refundable)
Use Fee	\$10.00 per hour, \$35 for 4 hours, to max. of \$60.00 for full day. Use fee is discounted 50% if done in conjunction with reserving the Centennial Building.

Tennis Court	(no difference between resident or non-resident)
Reservation Fee	\$10.00 (non-refundable)
Use Fee	\$10.00 per hour up to max. of \$80.00 for full day. Use fee is discounted 50% if done in conjunction with reserving the Elk Ridge Main Area (Lion's Bldg. / pavilion / basketball court.)
Equestrian Arenas	(no difference between resident or non-resident)
Reservation Fee	\$10.00 (non-refundable)
Use Fee (per arena)	\$10.00 per hour up to max. of \$80.00 for full day

General Notes re: Park reservations.

- Reservation Fees are non-refundable
- Facility Use Fees are refundable if the city is notified two weeks prior to the reserved time.
- Deposits are refundable if the facility/field is left clean and without damages and the key is returned. Deposits, if not refunded, is intended to cover the cost of re-keying a facility if a key is lost, and/or extra cleaning of the facility beyond normal use if such is needed. If the cost of cleaning or damage repairs resulting from use of any facility exceeds the deposit, the City reserves the right to charge the user for any additional costs incurred.
- **Buildings and Parks Rentals:**
No park rental refunds will granted due to inclement weather unless the pavilion/area is deemed unsafe or unusable."

General Notes re: Park & Recreation Fees.

- **Youth/Adult Sports Programs & Activity Registrations:**
The North Logan Parks & Recreation Department will withhold 25% of any registration paid for recreational programs to cover administrative costs. No refunds will be given after the league schedule has been made, once online registration has closed, or after the first day of the program/event (whichever comes first).
- **Reduction or Waiver of Recreational Fee due to need:**
The City Administrator, in conjunction with the Parks & Rec. Director, will review applications for the **Fee Reduction/Fee Waiver Program**, which is designed to encourage all children to participate in recreational programs regardless of financial circumstances. These will be reviewed on a case by case basis, and determination of fee reduction or fee waiver will be made at the sole discretion of the City Administrator and Parks & Rec. Director.

These new fee shall be effective the 7th day of September, 2011.


